Comprehensive Family Support: Home-based services provided to families with children ages 0-18 with a goal of strengthening parent-child relationships, linking families to community services, educating parents about child health and development, improving parenting skills and self-sufficiency, and preventing child abuse and neglect.

4b (Code: ) (Expenses \$ 176,234. including grants of \$ 0.) (Revenue \$ 0.)

Healthy Families: is a nationally recognized evidence-based home visiting program model designed to work with overburdened families who are at-risk for adverse childhood experiences, including child maltreatment. The target population for this program is Medicaid-eligible first time pregnant women under the age of 21 and their children. Services begin prenatally and continue until the child turns three years old.

Personal Responsibility Education Program (PREP): is designed to provide comprehensive sexual health education to young women in order to prevent pregnancy and sexually transmitted infections, including HIV/AIDS. The program targets Sullivan County women ages 15-19 and pregnant youth and mothers under the age of 21.
